## From the Director

As we begin 2011, it is a great pleasure to report on the successful completion of our first year of construction on the Museum's transformational expansion—work that would not have been possible without the generous support of the Museum's family of donors. Gifts at all levels have raised more than \$142 million toward the \$145 million goal of *The Campaign for the Saint Louis Art Museum*, the largest capital campaign for a cultural institution in St. Louis history.

Remarkable progress has been made both outside and inside the Museum since breaking ground last January. The new, underground Parking Garage has been completely enclosed, and the first walls of the East Building have been erected. Inside the Museum, construction is underway on a staircase that will provide a clear connection between Sculpture Hall and the Level 1 galleries, cafe, and Parking Garage, as well as the Education Center, Museum Shop, and Auditorium. Anticipated milestones on the expansion project in 2011 will mark the beginning of a series of collection reinstallations planned for the Cass Gilbert–designed Main Building.

The future of the Museum continues to be bright thanks in no small measure to the continued generosity of the entire St. Louis community. We are grateful to recognize the significant support of the Metropolitan Zoological Park and Museum District, one of the largest tax supported cultural districts in the country. Each year, however, it is the funds from our donors that allow the Museum to continue providing a full schedule of dynamic and diverse exhibitions and programming.

The individuals and organizations that have made a commitment to the future of this great institution with gifts in 2010 are recognized on the following pages. On behalf of the Board of Commissioners, the Trustees, and the entire St. Louis community, I thank you for your continued support. Your commitment to the Museum is an enduring legacy for future generations.
